Criteria for shareholders to propose the Director Nominee

The Company has set the criteria for minority shareholders nominate candidates to be nominated for the position of directors by nominating them through the Company Secretary in advance of the Shareholders' Meeting, together with information on qualification and consent of the nominated shareholders.

The qualifications of the shareholders to nominate persons to be considered for the position of the aforementioned directors.
